b. President's Report and Updates- Jennifer Strohm

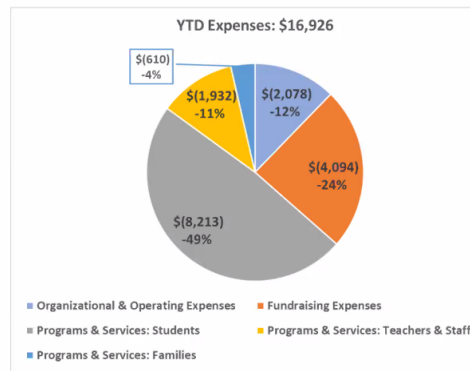
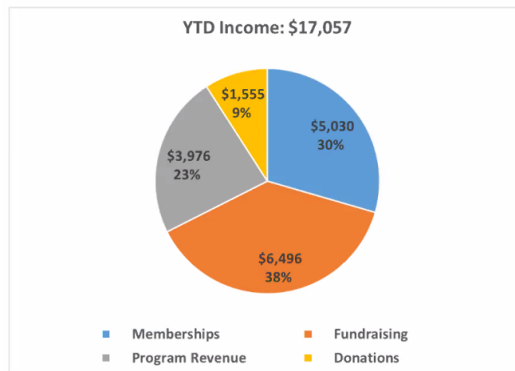
- i. PTA Directories are in.

d. Advocacy, Ansalan Stewart

- i. The Advocacy Committee's charge is to develop an advocacy plan in support of all BRES students achieving success. It agreed the overcrowding issue was the most urgent issue and is currently in the information gathering phase. It found since opening the student enrollment has outstripped projections. BRES has a population of 768 students at a school built for 740 students.

e. Principal's Update- Kathryn West

- i. Mrs. West gave an update on enrollment. There was an increase of 74 students between 8/30/21 to 2/3/22. There are 8 students in MCPS Virtual Academy. She also gave an update on staffing. Recent allocations include 2 FTE teachers, 1 FTE ESOL staff, and .5 FTE for School Counseling. She also discussed lowering class sizes.
